About Cattle Producers Australia

Cattle Producers Australia Ltd (CPA) is the new representative voice for Australia's grass-fed cattle producers. All grass-fed cattle transaction levy payers are entitled to **Free membership, voting rights and the opportunity to stand for election**. A Policy Advisory Council will be elected from 15 regions across Australia and control of CPA will be directly in the hands of grass-fed levy paying cattle producers. The Policy Advisory Council will be responsible for establishing CPA's Policy platform and Councilors will be eligible to stand for election to the 7 person CPA board of directors in a nation-wide ballot every 4 years.

The CPA board will be responsible for implementing the Policy platform, managing CPA's member services business and providing corporate governance to CPA. If there is any dispute between the CPA board and the 15 person Policy Advisory Council on Policy issues then that issue will be put to a Members Survey whose decision will be binding on the CPA board.

What CPA wants to achieve

In line with the recommendations from two recent Senate inquiries and an ACCC Cattle and Beef market study, CPA aims to become a truly representative voice for the Australian grass-fed cattle producer.

Your membership eligibility and voting entitlements

The Constitution requires that a CPA member must be a Grass-Fed Cattle Producer that paid Grass-Fed Cattle Transaction Levies (Statutory Levies) with respect to a Property or Properties that the Grass Fed Cattle Producer owns or wholly or partly leases or agists within the previous financial year. The Grass-Fed Cattle Producer must either hold a Property Identification Code (PIC) with respect to that Property or those Properties or utilizes the PIC held by the owner of the Property or Properties.

CPA Members voting entitlements are subject to CPA's right to require verification of the amount of Statutory Levies paid by the Member in the previous financial year.

A CPA Member who is entitled to vote will be entitled to one vote for a delegate to represent them on the Policy Council from the Region in which they paid Statutory Levies in during the preceding financial year

All Policy Advisory Councilors will be eligible to stand for election on the CPA Board.

A 7 person CPA Board will be elected by a nation-wide ballot conducted through two voting Registers with each CPA member entitled to one vote in:

- Register A; and
- Register B and an extra vote for every \$1000 in cattle transaction levies paid by that member in the previous financial year.
